2012 Cruze Drawing Eligibility Rules

The United Way of Trumbull County (UWTC) will award a 24-month lease on a 2012 Chevrolet Cruze, donated through the courtesy of Diane Sauer Chevrolet, Inc., to an individual whose personal contribution (check, cash, payroll deduction) to the UWTC's Campaign 2011 equals or exceeds \$120.

The names of all qualified contributors must be provided to the UWTC prior to the date of the drawing; the United Way of Trumbull County shall not be held accountable for the failure to submit eligible entries. Small business owners, who make their personal contribution in the name of their business, will be eligible for participation. Payment of at least \$120 must be made prior to the awarding of the vehicle lease.

The 24-month Ally Bank lease on the 2012 Chevrolet Cruze has an approximate MSRP of \$18,465.00. Prize will consist of fully subsidized payments for the term of the 24-month lease. The winner will be responsible for paying all local, county, state and federal taxes, as well as all title, registration, document fees, insurance, and any other fees associated with the lease of the automobile. The winner will be responsible for the excess mileage greater than 24,000 miles for the two-year period (at a cost of \$.20 per mile) and will assume vehicle damage responsibility.

Prior to taking possession of the prize, the winner must show proof of a valid driver's license, automobile liability and collision insurance. Winner must apply for and be approved for an Ally Bank lease. In the event that Ally Bank discontinues its leasing program, all attempts will be made to place this lease with a comparable bank or lessor, but neither Diane Sauer Chevrolet, Inc., nor United Way of Trumbull County, shall be held responsible for Ally Bank's leasing decisions.

The lease is not transferrable, redeemable for cash, or exchangeable for any other prize. The prize must be redeemed within 60 days of the date of the drawing. If a winner is not eligible or cannot be contacted, UWTC reserves the right to determine an alternate winner at its sole discretion. Proper identification will be required upon presentation of the vehicle. The drawing will be held in March, 2012 after the conclusion of Campaign 2011.

Participants and the winner must be U.S. residents and at least 18 years old. Only one entry per person will be accepted. Employees of Diane Sauer Chevrolet, Inc. and United Way of Trumbull County and their immediate families are not eligible to participate. The term "immediate family" includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as "in-laws" or by current or past marriages, remarriages, adoption, co-habitation or other family extension, and any other persons residing at the same household whether or not related. Corporate contributions and charitable foundations are not eligible. The contest winner agrees that the United Way of Trumbull County may use his/her name and/or likeness for publicity purposes. The winner will be required to sign a release and hold harmless agreement in favor of the United Way of Trumbull County and its respective agents and employees.
