LETTER FROM THE PRESIDENT

2020 was a year unlike any of us have seen. While 2020 presented significant challenges, it also illustrated the important role United Way of Trumbull County plays. The year began with the approval of our 2023 Strategic Plan but quickly pivoted to providing direct and indirect support to individuals, families, and agencies in Trumbull County.

In direct response to COVID-19, we coordinated volunteers to make masks for essential workers when PPE was not readily available and provided 288 gallons of hand sanitizer to partner agencies to keep their staff and the people they serve safe. Through our COVID-19 fund, we addressed food and housing insecurity and provided increased funding to our front-line partner agencies as the demand for their services continued to grow. We provided diapers to families in need, school supplies to students, kept kids engaged with virtual Read Aloud sessions and recognized our front-line workers through our Thankful Acts of Kindness Initiative.

We also never lost sight of our day-to-day work as we continued to fund more than 20 local programs to help people in our community get the opportunities they need to build toward self-sufficiency. We remained focused on early childhood literacy and introduced the Ohio Governor's Imagination Library and broke ground on a new Born Learning Trail in Warren. And, as the cost of prescriptions continued to rise and the need for assistance grew, Women United of Trumbull County provided more than 200 prescriptions for insulin to underinsured seniors and others.

United Way of Trumbull County was founded because of challenges like those we have seen during this pandemic. What we do well is collaborative, strategic, big-picture work that no one agency can do on its own. By setting goals and coordinating with others we make an even bigger difference in our community.

As we look to 2021, there are encouraging signs. There are jobs coming to Trumbull County. There is new construction. Our restaurants and sports venues are reopening. And we look forward to working in partnership with all of you to Recover, Reimagine and Rebuild so that all children and families in Trumbull County can Thrive.

ACHIEVEMENTS IN ORGANIZATIONAL EXCELLENCE

In 2020, United Way of Trumbull County once again achieved all nine core requirements of United Way Worldwide. It is critical that our donors and volunteers are confident in their investment with United Way of Trumbull County. United Way of Trumbull County is proud to announce the following achievements that allow those that contribute to our organization to be confident in their investment.

United Way of Trumbull County has once again earned the Platinum Seal of Transparency from the non-profit leader, Guidestar, the world's largest source of non-profit information. This is the highest level of recognition offered by Guidestar and allows our donors to focus on the progress and results of United Way of Trumbull County. RESPONDING TO THE CRISIS

COVID-19 FUND

United Way of Trumbull County worked in collaboration with local foundations to ensure donations were getting to those in need by coordinating efforts, identifying gaps, and streamlining procedures to avoid duplication.

SURVEYS

During the pandemic, United Way of Trumbull County also conducted three surveys in Trumbull County. The information helped identify trends and local needs, better enabling the organization and its community partners to provide much needed resources and support during the ongoing pandemic.

Children, adults, and seniors experience the impact of COVID -19 differently, but the surveys revealed that mental health assistance is a high priority for each group. The last survey responses showed a 10% uptick in the need for mental health assistance as people continue to struggle with the stay-at-home order and the rapid depletion of financial reserves.

MASK DISTRIBUTION

Early on in the pandemic, getting PPE to essential workers was a challenge. At the direction of the Trumbull County Health District, United Way collaborated with local volunteers to make cloth masks and distribute them to those in need. United Way of Trumbull County and several Dollar General stores served as designated drop-off locations. JoAnn Fabrics provided discounted fabric and supplies as well as finished masks and the Youngstown Air Reserve Station provided masks for distribution once their quota was made. Volunteers making the masks were from all over Trumbull County including employees from Trumbull County Children Services. The masks were distributed to essential workers at local non-profit agencies, assisted living facilities and nursing homes, grocery stores, local health organizations, and to individuals upon request.

NEARLY 1,500 MASKS WERE DISTRIBUTED.

Both Employees and Children at the Pandemic Care Center at NEO Children's Rehabilitation Center received masks.

HAND SANITIZER

We distributed 288 gallons to our partner agencies for their safety and the safety of those they serve.



DIAPERS

As incomes as well as the distribution chain was impacted by COVID-19, families suddenly found themselves in need of diapers. Women United of Trumbull County helped raise funds to purchase diapers in bulk and distribute them through our local partner agencies. Over 1,000 diapers were provided to local families in need.

Litco International Inc. in Vienna not only raised funds, but also conducted an employee diaper drive. JoeAnn Coleburn, Human Resource Administrator from Litco Manufacturing and Women United Steering Committee member, helped coordinate the effort.

VIRTUAL READ ALOUDS

We introduced Read Aloud Wednesdays in the summer of 2020 for kids staying at home during the pandemic.









THANKFUL ACTS OF KINDNESS

Thanks to a generous donation from a private donor, we recognized our frontline essential workers with THANKFUL ACTS OF KINDNESS to show our appreciation for the sacrifices they made during the pandemic. We accepted nominations for a month in the spring and again in fall. Weekly, we chose one individual or group to be recognized. Each person received a small gift or meal purchased locally to show support for small businesses and restaurants such as Just Pizzelles, Vasillio's, Independent Avon Representative Georgann Learn, and Ritual Earth during the stay-at-home order. In a December newspaper ad, we thanked all the nominees for going over above during the crisis.

BORN LEARNING TRAIL


In the early fall, we began work on a new Born Learning Trail in Perkins Park! The trail's theme of **WATCH! STOP! LEARN! PLAY!** encourages parents and caregivers to follow the child's lead, building the child's curiosity and confidence, and reinforces learning opportunities present in everyday life.

The Born Learning Trail supports language, literacy, and social skills development, and reminds us that learning can be fun!

We know increased investment in pre-K development fosters healthy growth, decreasing the likelihood of children being affected by various other adversities later in life. Because of the power of early learning, United Way has established kindergarten readiness as a LEARN WELL area of focus.

SEEKING TO IMPROVE LEARNING EXPERIENCES, EDUCATIONAL OPPORTUNITIES & ENRICHMENT EXPERIENCES





This initiative includes three programs, each designed to increase the number of Trumbull County children reading at grade level by grade three, with an emphasis on children from low-to moderate-income families.

In 2020, our programming efforts took a back seat to more urgent needs. However, **READ 4 FUN** was a great success in late February when 130 volunteer readers visited classrooms throughout Trumbull County to read to 4400 students as part of Read Across America. **READ 4 FUN** helps build students' confidence and creativity through fun reading experiences with the help of community volunteers.

In the summer, United Way of Trumbull County volunteers produced **VIRTUAL READ ALOUDS** for kids to stay engaged with reading during their break and to keep reminding young children that reading is fun!

United Way of Trumbull County also helped students to succeed by providing book bags, school supplies, and pantry items.

A special thanks to Premier Bank, Litco Manufacturing, Inc., and the ladies at the Trumbull Regional Gift Shop for making this possible in 2020.




SUPPORTING A HEALTHY COMMUNITY


PEOPLE HELPED: 1,992

% of Prescriptions by Therapy Area








